Supplementary Regulations

1. *The event will start at 11.00am sharp on both Saturday & Sunday at Lagan Quarry, Aughamore, Co Sligo. Venue is approx 4km from Sligo on the R287 Dromahair Road. Exit Dual Carriageway @ Junction S2. Co ordinates N 54 2365 and W 08 45120*
2. *Valid Competition Licence must be available for checking at sign-on. **One Day event licences will be available for these events.** (details from Event Secretary)*
3. *Sign-on at the venue from 9.30am each day. Drivers Briefing at 10.45am on both days with no walking of tests after this time – Failure to attend may incur 5 sec. penalty. **Please note that due to daylight restrictions these times will be strictly observed.***
4. *Drivers **must** run in (class / test) order as indicated at drivers briefing*
5. *More than one driver will be allowed per car. No driver may compete in more than one car.*
6. *The tests will be designed to suit all types of cars equally*
7. *Time cards will be issued for each lap in accordance with App.90 8.12, and must be handed into Chief Timekeeper after each lap of three tests*
8. *The time taken for each test will be taken as being the penalty for that test. Additional penalties may be incurred as follows: -*
 - a) *Each initial contact with a pylon - **5 seconds***
 - b) *Each line fault - **5 seconds***
 - c) *All lines must be crossed by leading wheels only i.e. astride all lines*
9. *Maximum loss (including failure) in any test will be “the best correct performance **in Class** plus 20 seconds”*
10. *Ties will be decided by the better time (including penalties, if any) on Test 1 and so on until the tie is resolved*
11. *This event will have two types of tests with all Hewison tests being run on sealed surfaces and clubman classes on loose surface so suitable for Endurance type cars.*
